Recognition and screening of distress in patients with cancer Kathleen McBeth, MA - Cancer Patient Support Program Coordinator, Fletcher Allen Health Care



The emotional impact of cancer can be devastating to the patient and is frequently accompanied by shock, disbelief, anger, anxiety, depression, and difficulty in performing activities of daily living. The 2012 Standard of the American College of Surgeons: Commission on Cancer (CoC) will require accredited institutions to develop and implement a process to integrate and monitor on-site psychosocial distress screening and referral for the provision of psychosocial care as the standard for patients with cancer. This talk will discuss the psychological issues in cancer, timing of screening, assessment tools, referral process, and documentation recommended to achieve this standard.

#### Are Anthracyclines a Necessary Component of Adjuvant Chemotherapy for Breast Cancer? Michael Hassett, MD, MPH, Dana-Farber Cancer Institute; Assistant Professor of Medicine, Harvard Medical School

This session will review current data on the benefits/lack of benefits of anthracycline and other agents in subsets of breast cancer.
